COURSE INFORMATION

This qualification covers the skills and knowledge required for a qualification in carpentry, covering work performed in residential and commercial applications.

This qualification has been specifically developed to meet the needs of the construction industry.

The construction industry strongly affirms that training and assessment leading to recognition of skills must be undertaken in a real or very closely simulated workplace environment and this qualification requires all units of competency to be delivered in this context.

While undertaking this qualification, the apprentice will gain the skills and knowledge to interpret building plans and specifications and the apply WHS requirements, policies and procedures in the construction industry.

The apprentice will work with a range of tools, equipment and materials to construct frames for walls and ceilings, construct pitched roofs, and erect and dismantle form work for footings and slabs on the ground.

COURSE OUTCOME

Successful completion of the course will result in the issuance of a Certificate of Qualification and a nationally recognised Statement of Attainment for CPC30220 - Certificate III in Carpentry.

COURSE PREREQUISITES

There are no prerequisites for this course.

ENTRY REQUIREMENTS

Participants must be employed and registered under a training contract as an apprentice and must obtain the General Induction White Card before commencing work on a construction site in Australia.

Tec-NQ conducts a learning, literacy and numeracy assessment as part of its enrolment process.

TRAINING & ASSESSMENT

Training is delivered by Tec-NQ and can be a combination of:

- Online theory
- On-the-job blended learning
- Face-to-face facilitator lead instruction in both practical workshop and classroom contexts
- Online logbooks

Tec-NQ will employ a range of assessment methods designed to gather evidence from a variety of sources in different forms. The evidence gathering techniques will be direct, indirect and supplementary.

COSTS/ CONCESSIONS

Fee-Free Training for Under 25s. Tec-NQ apprentices may be eligible for the Queensland Government's Free Apprenticeships for Under 25s Incentive, which covers the cost of your training when you choose a high priority apprenticeship or traineeship. Up until 31 December 2024.

Eligible apprentices who meet the Queensland state funding requirements will be charged a set fee of \$1.60*/nominal hour. Certified training is GST free.

Nominal hours for each unit of competency are provided in the training plan.

Fees are set by the Queensland Government department that is responsible for training. Fees are subject to change over the course of an apprenticeship.

Some students may be eligible for concessions. Please check with your enrolments officer when registering for the course.
